Generally, 3 items can be picked up for Free.

When disposing of appliances, all food and debris must be removed prior to collection. Remove or secure doors to eliminate potential hazards to children. When disposing of lawn equipment, gasoline, oil and any other fluids must be removed before collection.

 - Placement fine, recommend trimming trees back a bit (Bill/Donald Allen)
 - 2. Water needed during 1st year, but should be ok if planted during the fall
 - ii. We can add a drip line with a hose connection if neighbors are willing to drag a hose and connect to it. The cost for this would be \$175. Waiting until spring/summer to see if we need it.

- iii. Tree Update (Chris): Wait until next spring.
- 3. Playgrounds: In Progress
 - a. Trash Can lids: Need to paint 2nd spare can (Chris to follow up)
 - b. Cleaning: Follow up with Barrs: (Marie)
- 4. Drainage & Lake Maintenance: (Steven)
 - a. Clermont Steps to Lake Project: Semi-Final Review
 - Tom Konsler: Management of 6'-7' platform at top (made of trex), and constructing steps on top of existing steps (existing may prevent erosion)
 - Tom will re-bid project per RLC bid with 8x8 timbers with crusher run gravel
 - ii. RLC: \$2750 (I would also budget \$3000 for this and make sure we have a representative there to guide/mark areas). Need to update bid and will submit motion via email on 11/11.

 - ii. Motion 2: To authorize Donald Allen to cut up and remove a dead tree that fell onto the dam, the 15 ft of trunk still standing, and a broken branch hanging from a tree on parkland 75 ft west of Sedwick Park for \$550. Approved via Email.
 - iii. Motion 3: To authorize Donald Allen to cut up and remove a dead tree at 123 Montclair for \$850. GL Code #05078. Seconded. Motion Approved.
 - b. Work in Progress: Evaluate tree policy? Clarify costs.

Motion to Plant (7) Chindo viburnum at 4-5
Feet Tall at an approximate spacing of 5ft, replace (3) existing plants, provided and installed by Rescue Lawn Care at a cost of \$775. GL Code 00458 Landscaping. Seconded. Motion Approved in committee. Seconded. Motion passes with one opposed.

Motion to accept Rescue Lawn Care's proposals for both Plantings/Landscaping (\$7140 per year / \$595 per month) and Grounds Maintenance (\$72,255 per year / \$6021.25 per month) services. These contracts will use GL Code 00458 (Landscaping) and GL Code 00531 (Grounds) respectively. Second. Motion passes unanimously.

Motion to accept Rescue Lawn Care's proposal to replace the landscape timbers South of Clermont road at the lake access with a 6' wide stair using 6x6 pressure-treated lumber, at a cost not to exceed \$3000 using GL Code 00589 (Trail Maintenance). Tabled until the next Meeting of the Board.



Overview

 Incorrect email addresses for Wray and Marie identified, necessitating updates to the email distribution list for future communication accuracy.

- NCDOT approved modifications for signage design, switching to a single-pole, with \$1,900 manufacturing cost and \$182.50 permit fee per sign; installation timing affected by ongoing Sedwick Road construction.
- City mandates permanent vegetative features for sign bases, requiring minor design alterations and board approval for a \$1,000 refundable security deposit.
- Playground survey revealed maintenance and pest management issues; potential senior fitness projects discussed without commitment to grant applications as of yet.
- Maintenance responsibilities for playgrounds confirmed under Parks and Lawns; tree watering efforts by volunteers noted as insufficient.
- Trail development efforts led by David Sokal face volunteer shortages; Steven Berkowitz plans to consult original builder Stewart Bryan for potential improvements.
- Traffic speed and volume study initiated with a 9-12 week evaluation time frame; Parkwood's location limits prioritization for improvements impacting the timeline.
- Ongoing paint and maintenance work at the office building reported; redesign of signs to



durable materials under review by Mike Brooks.

 The next PPC meeting scheduled for November 18, 2025, at 7 PM to further address progress and challenges.

Motion to authorize the President or member of the Executive Committee to take necessary steps to procure a Cashier's check for \$1000 to be drawn from GL-06027 PPC Engineering to be delivered to the appropriate NC DOT authorities, upon receipt of all necessary permits from the City of Durham for the Sedwick Road signs. This check will be held in reserve to serve in lieu of the State's required performance and indemnity bond. The authorization in this motion shall expire if not exercised prior to January 1, 2026. Second. Motion passes unanimously.

Motion to authorize the president or a member of the Executive Committee, in the event of the denial of either or both permit applications currently pending for the City of Durham for the Sedwick Road Signs, to file an appeal with the appropriate City authorities. Second. Motion passes unanimously.
